

Jet2.com Prize Draw Terms & Conditions – MADEIRAJ2HS26 Flights Prize Draw

This prize draw is promoted by Jet2.com Limited (registered number: 02739537) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2.com", "we" or "us"). By entering this prize draw, you are deemed to accept these terms.

1. This prize draw opens at 10:00 on 31/07/2026 and closes at 23:59 on 01/09/2026.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2.com, Jet2holidays Limited, Jet2 plc or any other companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter.
