

## **Terms & Conditions – Spin the Wheel – Manchester Marathon**

This prize draw is promoted by Jet2holidays Limited (registered number: 04472486) whose registered office is at Low Fare Finder House, Leeds Bradford Airport, Yeadon, Leeds, West Yorkshire, LS19 7TU ("Jet2holidays" or "we" or "us"). By entering the prize draw, you are deemed to accept these terms:

1. This prize draw will open at 10am on 19<sup>th</sup> April 2026 and close at 6pm on 19<sup>th</sup> April 2026.
2. Entrants to the prize draw must be residents of the UK, the Channel Islands or the Isle of Man and must be aged 18 years or over. Employees and officers of Jet2holidays, Jet2.com Limited, Jet2 plc or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. An entrant may only enter the prize draw once.

### **How to enter:**

3. Jet2 will be in attendance at mile 22 of Manchester Marathon with a prize wheel for attendees to spin.
4. To enter, participants will have to enter their name, phone number and email address on a tablet and spin the wheel to win a prize in between the times stated in paragraph 1 above. The prize won will be the one that the wheel segment corresponds with, unless those prizes have run out. If the prize landed on has run out, the entrant will be permitted to spin again until they win a prize.
