

Bon Voyage Terms and Conditions

1. To enter you must be aged 18 or over and live in Great Britain (Scotland, England and Wales) or Northern Ireland. Employees and officers of Jet2holidays ("Jet2holidays"), Jet2.com Limited ("Jet2.com"), Jet2 plc or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter.
